- The Government of Nepal [GoN] *has allocated funds* towards the cost of **CONSTRUCTION OF 15 BED HOSPITAL** and intends to apply part of the funds to cover eligible payments under the Contract *for CONSTRUCTION OF 15 BED HOSPITAL (Contract No : TRM/ROLPA/WORKS/10/2077-78)*. Bidding is open to all eligible as per Section V of bidding document.
- Triveni Rural Municipality** invites electronic bids from eligible bidders for the construction of **CONSTRUCTION OF 15 BED HOSPITAL** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Tribeni Rural Municipality, Jungar, Rolpa, Lumbini Province or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- If hard copy is allowed a complete set of Bidding Documents may be purchased from the office **Tribeni Rural Municipality, Jungar, Rolpa** and by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **Nrs 10000** till **February 12, 2021 during office hours**.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

- Pre-bid meeting shall be held at **Tribeni Rural Municipality** at **January 31, 2021 on 14:00 hours**.
- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours** on **February 14**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **February 14, 13: 00 hours** at the office of **Tribeni Rural Municipality, Jungar, Rolpa** . Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs 40,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid .
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Bidders may withdraw or modify its bids by sending a written notice in a sealed envelope, duly signed by authorized representative, and shall include a copy of authorization in accordance with ITB 20.2 before 24 hour prior to the deadline of submission of bids.
- Bidder may submit modification or withdrawal prior to the deadline prescribed of submission of bid through e-GP system by using the forms and instruction provided by the system. Once a bid is withdrawn bidder will not be able to submit another bid response for same bid.
- After the completion of evaluation of technical bids, which are substantially evaluated bidders will be invited to open the price bids. The date, time and location of opening of price bid shall be notified in writing and or published on national daily.
- Other mandatory information will be as per Public Procurement Act, 2063 (PPA) and Public Procurement Regulation 2064 (amended).
- If employer wants, he/she can reject all or any of the bids.
